Monthly Ministers' Article: Roots and Wings

In February, Phyllis invited Gita Deane and Lisa Polyak to take part in a service focusing on marriage for same gender couples. Gita and Lisa were the lead plaintiffs in the ACLU lawsuit to establish the right to marry for same gender couples in Maryland, a suit which failed by just one vote in the Court of Appeals. They shared some of their very moving story. In her sermon Phyllis announced that she had come to the conclusion that as a matter of conscience, she feels she can no longer act as an agent of the state in signing marriage licenses even for heterosexual couples, at least while Maryland continues to deny this right to same gender couples.

Both of us join in this conclusion. Because not everyone was at that service, and because our witness would have some limited implications for this congregation, we want to share with you our reasons and answer some of the questions you may have.

As we have worked with dozens of couples over the years in preparing for holy unions and religious marriages, it has become clear to us that couples of the same gender bring to their marriages the same love as heterosexual couples. They want for their families the same opportunity to establish a safe and loving space in which to live, to raise children, and to serve the community.

Therefore it seems to us wrong for the state to bar them from the equal protections and the equal status that civil marriage brings. Lisa and Gita have had to pay thousands of dollars to lawyers to get at least some of the same rights that other couples take for granted. They were separated during the birth of their daughter. We think it is the state's role to protect the vulnerable, not enforce the views of particular religious bodies in the civil realm.

In many countries, even those where church and state are not separated, civil marriage and religious marriage are separate. To be legally married, you go to the courthouse. If you also want a religious marriage, you go to a church. In our country, where church and state have long been separate, it is surely an anomaly that the state still delegates to the clergy the right to perform a legal marriage on behalf of the state. This is the only area that we are aware of in which clergy act as agents of

the state, placing the two of us in the position of enforcing a discriminatory law.

A handful of other clergy, mostly Unitarian Universalists, have refused to sign wedding licenses until their states legalize civil marriages. Should Paint Branch support this action, it would be a leader on this issue. Initial talks with our colleagues indicate that Proposition 8 in California and the loss of the ACLU lawsuit in Maryland might have created a climate which may lead other clergy to join us.



Let's talk about the consequences. We will continue to perform religious ceremonies. At present, we have no weddings scheduled at Paint Branch so our

decision is likely to have little immediate practical impact. We invite any couples who may be planning a ceremony before we leave to contact us to discuss the situation. We hope the Board will support us in this act of conscience, but because we have made this decision in the middle of the church year, we want to work with you. Couples wishing a legal ceremony would need to take part in a civil ceremony before a clerk of the court. This would mean an extra trip to the courthouse, and an extra \$25 in fees.

For Paint Branch, this could mean some loss of rental revenue, if some couples choose to go elsewhere to be married to avoid the inconvenience of two ceremonies. In practice, however, even before this decision, we have so far performed only one nonmember wedding at Paint Branch this year. We hope and expect that if this church becomes known for this stand it will attract more couples, both straight and gay.

What can you do? We hope that you will support us in our act of conscience. We have discussed this with Rev. Keith Kron of the UUA and with Equality Maryland, both of whom support our stand. We will be discussing this with the Board so that we may together consider all the implications for us and for the church. We have been thinking of this for some time. The exact date of implementation is less important than taking the stand.

What else can you do? We hope that our declaration will start a conversation within the congregation. After all, we are only here for a year. It is up to this congregation, working with its new minister, to determine how best to live out its mission as a Welcoming Congregation supporting justice for all people.

Paint Branch could become one of the first churches in the country to declare that it will allow only religious services in its sanctuary, again as a matter of conscience. Individuals could go as a group to Annapolis for Lobby Day next year, write letters, make phone calls – informing their delegates that we, too, are religious people – telling them that we believe more love is needed, not less, asking them to stand up for the vulnerable citizens of this state who have done nothing wrong except love the wrong person. These are the kinds of action that might make our representatives take notice. The ones we have spoken with tend to think all religions oppose same gender marriage. They need to hear from us.

We hope this is an idea whose time is coming. It astonished us last month, at Equality Maryland's Lobby Day, when a legislator in our own, very conservative, district in Baltimore County suggested to us that Maryland should offer civil unions to everyone.

As the choir sang at our service, "We will not give up the fight, we have only started." Let us start this new path on the way to justice.


From the Board Chair

A simple majority vote is not enough; it is essential to have close to ninety per cent of the vote in favor of the candidate, in order not to have a divided congregation.

So many people do so many things, it would be impossible to name all those who contribute their time and talents to this church. Know that I am deeply appreciative of all that is so graciously given.

Board Treasurer Report: The upcoming canvass

A little straight talk about the canvass:

The canvass is a critical component of the financial picture of the church. It is held every spring asking for pledges for the following fiscal year (July 1 - June 30).

This year we need YOU to do two things:

- Make your own pledge promptly and,
- agree to be a Visiting Steward. Read on for more details.



The Budget Leadership Team (BLT) uses the sum of the pledges to put together the budget. Most churches discount the pledges a bit, expecting that not all the money will be received. However, at PBUUC, in recent years at least, we have

been budgeting the full amount. In addition we budget for an additional \$10,000 which we think will be received from new members and from casual visitors.

This forms the backbone of the budget. If the canvass does not go well, then the budget is pared down. Since we must pay salaries and heat the building, other things are short changed - principally maintenance and programs.

What has been our actual experience? In FY06 we received \$268,000 in pledges; in FY07, \$260,000; in FY08, \$282,463; and in FY09, \$261,252. It has been very difficult to adjust the budget to these gyrations.

Why do pledges go up and then down again? It can mean that we are losing members and this is true to some extent. Some of our long-term members have passed away or retired to other parts of the country. That happens in every congregation. And we do have new members. Perhaps their pledges are lower than those that were lost and this too is expected. It takes time for new members to become as committed as those who were here for decades. But this is not the whole answer.

I have been doing some extra work this year to keep track of pledges. One thing I have found is that there are some people who contribute regularly but who did not pledge. A few are new to PBUUC but a good number have been around for a long time. While we certainly appreciate the financial support, THIS DOES NOT HELP WITH THE BUDGET!! In order to put together a reasonable budget, we must base it on something concrete. And that is the amount pledged during the canvass.

Ideally, how would the canvass go? First, many people would volunteer to be Visiting Stewards (the new name for Canvassers). The new name indicates that the purpose is not only to obtain the pledge, but to find out how people are feeling about the church, what is working well for them and what is not, and what personal problems they may have. All this information is then funneled back to the ministers and the leadership so that we can become an even more intentionally supportive community.

I sometimes hear people say, "Oh, I don't want to canvass. I don't like doing that! A better response would be "It's not my favorite thing to do but I know how important it is, so I'll be glad to do my part." In workshops on Stewardship, professionals suggest that no Steward should be asked to visit more than 4 people (plus themselves). With that in mind, we need at least 30 Stewards to cover our congregation. With more Stewards, the work load of each can be even lower. May we count on YOU? (Call me if you are willing to be a Visiting Steward: 301-572-3983)



Another aspect of the canvass should be that all members and friends pledge willingly. No one likes to chase people for their pledges. Ideally, when a Visiting Steward

asks to visit you, you will get out your calendar and find a mutually suitable date. You would come to that meeting prepared to listen to input from the Steward and then make your pledge. It can be in your home, over coffee in a restaurant, or a quiet place to talk after church. Whatever works for you.

Can you help? Can you turn in your own pledge promptly? Can you offer to be a Visiting Steward? The health of PBUUC depends on your response.

Ministerial Search Committee

ARE WE THERE YET?

The Pre-Candidating Weekend starts with a casual dinner with the Ministerial Search Committee (MSC) and the candidate (and their spouse, if one has come). No formal interviews, no formal questions, just some time to get to know one another.

On Saturday, the interviews grow more intense with the MSC bombarding the candidate with questions gathered from discussions during the cottage meetings and your responses to the congregational survey. After a light lunch with the committee, the candidate is taken on a short tour of our facilities and our community. Later, one of our co-chairs sits down with the candidate to discuss the technical and financial details of a possible ministerial agreement between the candidate and the congregation.

Saturday night is free for both the candidate and the Committee. They come together again Sunday morning to listen to a worship service delivered by the candidate at a "neutral pulpit". The Committee then meets one last time with the candidate over lunch when everyone gets to ask some final questions. After lunch, the candidate leaves for home and the Committee talks a little about their impressions but does <u>not</u> yet take a vote.

No vote is taken until all pre-candidating weekends are complete. This is the culmination of months and months of work. If we agree strongly that one candidate is really the right match for our congregation (and that is a good possibility), then we will invite that candidate to come down for Candidating Week.



Candidating Week is an intense and exciting time for both the candidate and the congregation. The week runs from Saturday one weekend through Sunday of the next weekend. The Candidate will be meeting formally and informally with people representing the major areas of the church: the RE Director and staff, the Music Director, members of the choir,

the Church Administrator and staff, the RE teachers, the Worship Associates, the Pastoral Care Associates, the We Care Committee, the Social Action Committee and so on. The candidate also preaches a service at Paint Branch on both the first and last Sunday of that week.

There is more to say about Candidating Week and the final vote to call or not to call the minister, but I will save it for the next article. The MSC has reserved two weeks on the Church Calendar at the end of April: Saturday, April 18 through Sunday, April 26, and Saturday, April 25 through Sunday, May 3. If everything goes as planned, one of these weeks will be the actual Candidating Week.

Our only agenda is to find the ministry that is the best fit for our congregation. We're looking for a minister who leaves everyone with a strong conviction that the match is right for both parties. We will not settle for anything less.

The eight members of the Ministerial Search Committee are: Bettie Young (co-chair), Michael Léger (co-chair), John Bartoli, Beth Lyons, Rene McDonald, Muriel Morisey, Tricia Most, and Marge Owens. Please don't hesitate to stop one of us and ask about the search. Look for the big ID tags with the MSC logo.

RE Parents, RE Teachers Past and Present, RE Committee members, and Youth:

- What are the most important themes to YOU in our religious exploration program?
- Which children's R.E. courses have been the most meaningful to you and to your family?
- What would you most like to see offered in the future?

This spring we will be asking ourselves and one another these important questions as we end a three year RE curriculum cycle. With the new "Tapestry of Faith" series now available from the UUA, we have many new options, and more choices are arriving each semester! This variety of options is wonderful and the new series of curricula is excellent!

But it also becomes more important than ever that we:

- identify those curricula and themes which we value most to assure these will not be lost in the shuffle!
- determine what may be under-represented in our current curricular offerings and which we might hope to give greater emphasis in the future
- consider all the available options
- include many voices in the conversation and in the decision-making process

With the goal of hearing many voices, this spring's planning process will include the following steps:

- 1. A brief "RE curriculum survey" will go out to all RE families and teachers, and will also be available in the Meeting House foyer, from Sunday, March 1 through Sunday, March 15. Please take a moment to fill it out and express your preferences!
- 2. Curriculum planning meetings will take place during Enrichment Hours in March and April. Meetings have been scheduled for the following Sundays: March 15, 22, and April 19. We need a core curriculum planning team who will participate in these meetings, and be willing to bring some curricula home with them to peruse between meetings. - 5. At the **April 19 Enrichment Hour meeting**, we will report on the new curricula that we have evaluated, and complete the curriculum selection process for the near future.
- 6. Based on the previous steps in the process, the curriculum recommendations for next fall and beyond will be sent to the RE Committee for approval.

General Assembly, The Annual Meeting of Unitarian Universalist Congregations June 24-28, 2009, Salt Lake City, Utah



General Assembly (GA) is the annual meeting of the Unitarian Universalist Association of Congregations. General Assemblies make overall policy for carrying out the purposes of the

Association, directing and controlling its affairs. Voting at General Assembly is by accredited delegates from certified member congregations. Paint Branch is a certified congregation.

This year's Assembly will vote to adopt a new Statement of Conscience, Peacemaking. Our congregation has had several meetings and discussions, and submitted our statements to the UUA on the Congregational Study Action Issue (CSAI) that has led to this vote on the Statement of Conscience. There will also be considerable discussion on the latest CSAI, Ethical Eating, which our Minister Phyllis Hubbell discussed in a recent sermon.

This year there will also be a UUA Presidential Election. Our President for the past eight years, Rev. Bill Sinkford, has served out his final term, and a new president of the Association must be elected.

A great deal goes on at a General Assembly. There are frequently as many as 20 seminars conducted simultaneously, and they cover every imaginable subject of interest to UUs.
