The Minister's mUUsings...

ast month, on December 15th, the Council of the District of Columbia took an historic stand for love. By an 11-2 margin, council members voted to legalize marriage for lesbian, gay, bisexual, and transgender citizens. Marriage equality is coming to the nation's capital!

Rev. Rob Hardies, minister of All Souls Unitarian Universalist Church in the District and a leader of the interfaith coalition that supported the initiative, wrote in a public email that day, "It was thrilling to be present in the Council chambers as history was being made. When the vote was announced, people shouted and wept for joy. Friends, this is what it feels like to stand on the side of love."

Coming to Maryland from Massachusetts, where gay and lesbian couples have been able to legally wed since May 17, 2004, I know what it is like to officiate a legal same-sex wedding. The joy is exhilarating, out of this world! If happiness is a criterion for choosing an issue on which to devote your volunteer time, gay marriage is your issue!

The first gay couple I wed had been together for more than twenty years. They had never imagined they would ever be able to marry each other. Two women, and their eleven year old adopted daughter who stood with them, said their vows in front of four or five closest friends. Jubilant, victorious photos were taken afterwards under the rainbow flag hanging outside the front door of our 1825 meeting house. Who could have predicted it? What a day!

Intimate or very public, complex or simple, in a house of worship, wedding hall or outdoors— a wedding for two women or two men is so incredibly joyful, in my experience. There is the usual love to be celebrated, just like at a straight wedding. But at a gay wedding, there is also justice and history in the making and they are celebrated too.

In wedding ceremonies, I never used to mention my role as agent of the state, because I didn't feel comfortable with it. I still don't. I believe wedding licenses should be signed by a public official, not clergy.

But, starting in May 2004, I added a line to my typical wedding service script, "by the power vested in me by the Commonwealth of Massachusetts ... I do declare you, (name and name), to be love-fully and lawfully ... wed!" To date, I've not made it through that line at a gay wedding without pausing for euphoric cheers, clapping, whistling and even happy stamping of feet! I feel like crying every time!

Here in Maryland, I've decided (as did your interim ministers, I understand) not to sign wedding licenses until I can sign them for gay couples too. I will find and join (or help start if I have to) a multiracial interfaith coalition to support equal marriage in Maryland. I'm assuming you, the congregation, will want to be involved, too.

I'm thinking we will honor long-term relationships (hetero and homosexual) in our worship service on Valentine's Day, with a wedding cake reception during coffee afterwards. I'd like to publicize this in the community and invite gay couples in our area to attend. If you want to be involved in planning this, please let me know.

According to Hardies, "The Unitarian Universalist Association's 'Standing on the Side of Love (SSL) Campaign' made a big impact here in DC, providing our interfaith [equal marriage] coalition with a slogan to rally around, supporting our media outreach, and helping us go viral with video." He thanked UUs across the nation who supported the SSL campaign because its "efforts are making history." I hope we will avail ourselves of the Standing on the Side of Love materials too.

Of course, the struggle for marriage equality in DC is not over yet. The United States Congress has 30 legislative days after the Mayor's signature to veto it. I hope that the US Congress will respect the sovereignty of the elected leaders of the District of Columbia. Our support may be needed on that front. But, in the meantime, let's celebrate!

Notes from the Board of Trustees

BOARD OF TRUSTEES ANNOUNCES "RECLAIMING OUR SPACE" INITIATIVE

n Friday, November 20, 2009, at a Special Board Meeting held to discuss the lease renewal with the Paint Branch Montessori School, the PBUUC Board of Trustees (BOT) unanimously voted to not renew the lease which expires June 10, 2010.

The decision to not renew the lease with the Montessori School was made following a process of research and debate which took many months of work on the part of the current BOT; and was the culmination of years of discussion by previous Boards and the congregation at large. In making the decision, Board Members expressed enthusiasm and excitement over the opportunity together with sober awareness of the financial implications.

Some of the key factors in the decision were:

- PBUUC and Paint Branch Montessori School (PBMS) currently have a three-year lease between them which expires June 10, 2010. This lease calls for each party to notify the other of its intention to negotiate or not negotiate a new lease by December 15, 2009.
- In preparation for this decision, the BOT formed a "Space Options Task Force" in July 2009 to identify potential long-term rental options and use of space for the Religious Exploration Building. The Space Options Task Force provided a written report to the BOT in October. The Task Force recommended reducing our dependence on rental income, finding sources of rental income with less impact on our space, and retaining more of our space for full congregational use. Copies of the report are available from the Church Office upon request.
- Also during this autumn, the BOT became aware that a required Use and Occupancy Permit for the school's operations as currently defined by the State had not been granted by Prince George's County. The BOT consulted with a zoning attorney, who advised that although PBUUC has no direct responsibility for obtaining the school's permit, the process of obtaining the permit is complex, expensive, time consuming and could

involve the church in various ways including public hearings. Failure to achieve the necessary permit could likely result in the school being closed by the County.

- Another complicating factor was a determination last summer by the Maryland Department of Education that PBMS has been reclassified as a day care facility, rather than a school with before and after care, which subjected the school to a range of new standards and requirements. There has been no assurance from PBMS of their plans to meet these new requirements (which are both costly and logistically difficult). Failure to do so could also likely result in the school being closed by the state.
- Negative publicity for PBMS occurred last year when two young children wandered away from the school onto Powder Mill Road where a passing motorist rescued them. It is our understanding that this and other factors have resulted in a significant reduction of enrollment in PBMS.
- PBMS rents most of the space in the RE
 Building. Over the years, the wish that we could
 "own" our own space has been expressed by
 parents, children and teachers.

The immediate result of the BOT's decision was an exuberant blossoming of energy and excitement as we began to discuss the possibilities for use of our space in ways which demonstrate and foster our UU principals. BOT members expressed strong belief in the capacity of the congregation to "catch fire" over this new opportunity and meet challenges with enthusiasm and a full-hearted response.

Consequently, on November 30, 2009, the BOT sent notice to PBMS that the lease would not be renewed.

During December 2009 and January 2010, the BOT is holding a series of "mini town hall meetings" to provide background about this decision, provide a forum for expressing joys and concerns, and energize ourselves by imagining new and creative uses for this liberated space. Please join us during Enrichment Hour on January 10 or 17 to brainstorm together on our hopes and dreams for the Religious Education Building. We are hoping that each and every one of us will become involved in RECLAIMING OUR SPACE!

JOSEPH PRIESTLEY DISTRICT HEALTHY CONGREGATIONS LEADERSHIP TRAINING TO BE HELD AT PAINT BRANCH

October, congregation members identified the topic of **leadership development** as one of the major areas where Paint Branch UU Church needs to focus its efforts. We have been blessed as a congregation with many strong lay leaders during our first fifty-five years of existence. However, great congregational leadership doesn't just happen - there is much that we can be doing in order to recruit, train, and support new generations of leaders. Paint Branch in particular is a dynamic congregation where there is always plenty of leadership opportunities available – as members retire or move away, new leaders with new energy are needed in order to help the church move in new and exciting directions.

The Unitarian Universalist Association (UUA; www.uua.org) and our local Joseph Priestley District (JPD; www.jpduua.org) offer many resources for volunteers, committee members, Trustees, and other lay leaders. This spring, the JPD is sponsoring a series of workshops on the subject of congregational leadership called "Building Healthy Congregations." The dates for the workshops are January 16, February 13, March 13, April 10, and May 8, 2010. Each workshop runs from 9:00 am to 4:30 pm. The workshops will be held at PBUUC.

This workshop series is open to <u>teams</u> from congregations who are interested in revitalizing their congregation and learning new skills and new tools for congregational leadership. We are hoping to send a team of at least 5 members from PBUUC to this workshop. Team members must be willing to commit to attend all five workshops.

WAYS TO GROW LIFELONG UNITARIAN UNIVERSALISTS

I often meet people who left the church of their childhood or were not raised in any faith tradition but find their way to a Unitarian Universalist church after they have children. What they are looking for is providing their children with a moral compass in difficult times, they say.

As UUs though, we often have trouble figuring out whether we're trying to create "good UUs" or "wonderful people," says Kate Tweedie Erslev, a lifelong UU and author. She believes we need to do more to help our children understand that Unitarian Universalism is a faith tradition and not just a place to learn about religion.

"Neglecting to foster a UU identity is similar to leaving the meaning of the Bible to the Fundamentalists," she says in *Full Circle: Fifteen Ways to Grow Lifelong UUs.* "It is time we clarify who we are. When it comes to religious education, this means creating life-long learners, responsible decision makers and agents of transformation in the world who recognize the power of being in a UU community."

For the book, she talked with 82 women and men -- who were raised and remained UUs and ranged in age from 25 to 87 -- to find out what prompted their lifelong commitment to Unitarian Universalism. Those conversations led to *Full Circle*, which is available from the UUA bookstore (http://www.uuabookstore.org).

Many of the lifelong UUs she interviewed enjoyed their first taste of leadership in their congregations as teens by teaching religious education classes. The experience empowered them, they said, and they in turn took their responsibility seriously.

Another trait the lifelong UUs shared was attending services and classes regularly. "We offer support for a life-enriching, lifelong journey that involves the whole family through the calamities and joys of life," notes the author, who now goes by Kate Tweedie Covey.

Many of those interviewed remembered engaging Sunday classes with wonderful teachers, where learning was fun and they formed lasting friendships. And most talked about their transforming experiences with their congregation's youth group, which provided discussions about life's big questions, fun and friendship as well as opportunities to take on leadership roles and connect with adults.

These lifelong UUs recalled fondly memories of church-wide events such as potluck dinners and church fairs and annual events like Water and Flower services and Christmas Eve pageants. In addition, they remembered rituals marking life transitions such child dedications, coming of age, services of union and memorials. Ms. Covey suggests that it is "a balance between stability and change" that leads to lifelong memories and commitment.

Involvement in service projects that provided a chance to put their UU principles into practice, and included children, youth and adults, also played an important role for these life-long UUs. They also mentioned singing together and being in the church choir or inspired by the minister, teacher or church leader.

In the past, we UUs have often defined ourselves as "what we are not" rather than "what we are" and left our children to discover our implicit beliefs on their own. Today, we're doing a better job by using our Principles and Sources as guides for our religious education programs as well as our own lives.

"But we're still not articulating our UU identity very well," Ms. Covey notes. "It's time to put aside our reluctance to describe ourselves with a concrete identity and begin to describe the 'house' that we live in."

This is something I'll be thinking about as we start this new year together. And I'll be interested in hearing your thoughts as well. Karen Lee Scrivo Interim Director of Religious Exploration

Financial Notes

here is good news! The Legacy Fund is back at the \$100,000 level and the Legacy Fund Committee, led by Liz Citrin, has voted to make grants up to \$2,000 for the 2010-2011 church year. That can be one grant for \$2,000 or several grants that total that amount. So put on your thinking caps and submit proposals for things you think will benefit PBUUC.

In the past, grants have provided such physical improvements as the commercial dishwasher, an

upgraded PA system and the new sign on Powder Mill Road. Grants have also funded two program initiatives. First was the speaker, Jim Loewen, who talked about his book on Sundown Towns, towns where black Americans were once legally excluded after sundown. Another program supported by a grant was the Dedicated to Inspiring Vitality (DIV) workshop, led by Paula Cole Jones, which helped us develop our revised Mission Statement and laid the groundwork for the Strategic Plan that we will be developing over the next few years.

All proposals should be for projects that are NOT covered in the church budget; the more specific the proposal, the better. So provide backup for the expected costs and figure out who will be in charge of your project. It is expected that the approved project(s) will be completed by the end of the year for which it is made (in this case, by June 30, 2011).

The time table is as follows:

- 1) December: announce grant amount for the following year hence this announcement of the availability of \$2,000 for the coming year;
- 2) April 10, 2010: Grant proposals due to the Chair of the Legacy Fund Committee;
- 3) Mid-April to Mid-May 2010: Review of proposals by the Legacy Fund Committee;
- 4) Mid-May 2010: Selection of winning grant(s) by Legacy Fund Committee;
- 5) May 2010 Board of Trustees Meeting: Confirmation of grants by Board of Trustees;
- 6) June 6, 2010: Announcement of winning proposal(s) at the Annual Meeting.

Proposals should be submitted to Liz Citrin or the church office by April 10, 2010. The forms are available from Liz (Elizabeth.A.Citrin@nasa.gov) or Kevin Miller (kevin.a.miller@nasa.gov).

If you are looking for ways to benefit PBUUC over many years in the future, consider making a donation to the Legacy Fund. The Legacy Fund Committee intends to make grants each year of approximately 3% of the balance in the fund as of November of the prior year. Imagine what we can do if the fund were to double or triple or more. It is one way to provide the many things we dream of but can¹t quite cover in the budget.

RELIGIOUS DIVERSITY

pon review of the Unitarian Universalist principles and sources, the following source of faith comes to mind:

"Jewish and Christian teachings which call us to respond to God's love by loving our neighbors as ourselves."



As a Christian and Unitarian (a Christian Unitarian), I always wonder how welcoming we actually are of other religions and those who practice religions other than Unitarian Universalism. I must admit at

times, that I feel uncomfortable around others that do not share the same beliefs as me. I wonder if it is because I feel the need to defend my position, or maybe perhaps I would not feel accepted as a "Christian Unitarian." Maybe I feel uncomfortable because I may not fully understand the beliefs of another. Another possibility could be that my views may be considered somewhat conservative compared to the more liberal beliefs of most Unitarians.

Whatever the reasons may be, the above UU source of faith provoked questions within my mind, and I am sure in others, on how we can become a more welcoming church with regard to theological beliefs. In past articles, we have looked at issues of racism, the impact that it has within our community and what we can do to strive for diversity. What about religious diversity? How can we be more accepting of Christians, Jews, Muslims, Buddhists, and all other religions without making individuals feel excluded? How can we embrace each other's religious beliefs and differences and still feel that our own beliefs are valid, without getting angry or frustrated with those who do not believe as we do?

As an African American woman, I also look around at my church community at Paint Branch and I notice that there are few African-Americans, Indian and Asian members. I wonder how this could be since Paint Branch Unitarian Universalist Church is located in a predominately African-American county?

Could it possibly be because most African Americans practice Christian beliefs? What about Indians, Koreans, Chinese, Vietnamese and other racial groups? Does Unitarian Universalism extend welcoming arms to other culturally and religiously diverse minds? If not, how can we improve upon that?



I believe that in order to become a more diverse church, ethnically and religiously, we should strive to learn more about each other's beliefs and embrace differences. Further, we should respect and not try to nullify other religions whether those religions are Christianity, Judaism, Muslim, Hinduism, etc. The most important question that we, as Unitarian

Universalists should ask ourselves is "What or Who influenced us to be Unitarian Universalist"? Upon reflection of the answers to this question, we should immediately embrace theological differences for this is the true meaning of Unitarian Universalism.
