Yes, we are planning a grand event called an Installation for Sunday, March 14 at 4 pm.

Jokes aside, an Installation is a special worship service to celebrate the relationship between a new minister and the congregation that "called" him or her. The heart of the service is their declaration of a covenant between them, statements of mutual understanding and intent in which they make promises and declare their hopes for the ministry they embark on together, followed by "charges" given to each party. A "charge" is (often humorous) words of admonition and encouragement, don'ts and do's, offered by a respected person, received with humility. Of course, there is a Chalice Lighting, a sermon, and usually an offering for the Living Tradition Fund that supports UU ministers in financial distress—and, true to PBUUC's gifts, our Installation will include spirited music and dance, and be followed by a lovely reception. What may surprise you most is the procession of clergy in robes and colorful stoles. For Unitarian Universalist congregations, it is one of our few "high church" events.

The preacher will be the Rev. Kathy Huff, Senior Minister of our congregation in Oakland, California. Rev. John Gibbons, with whom I served last year at the First Parish in Bedford, Massachusetts, will give the Charge to the Minister. Mike Harris, lay leader from Cedar Lane UU Church in Bethesda and president of the board of the Joseph Priestley District (our Unitarian Universalist Association region) will give the Charge to the Congregation.

I hope you will plan attend the Installation and even help out with putting it on. Many hands make light work, you know, even if the plumber and mechanics are involved! So, I thank in advance the Installation Committee and its chair, Jan Montville (please be in touch with her to offer your help!), and everyone who helps prepare our space for guests, brings the fruit of their culinary inspiration, or ushers, sings, dances, puts up the coffee or otherwise makes it a day to remember, a true celebration of our shared ministry as Paint Branch Unitarian Universalist Church.

Notes from the Board Chair

re are living in troubled times. There are significant economic problems facing our nation and the world. In this congregation I know that there are people for whom the financial crisis is very immediate and very real. We have congregation members who have lost their jobs, who may be in danger of losing their homes, who have watched their retirement savings evaporate, and who are struggling just to get by. Nearly all of us have been affected by rising prices and other miscellaneous fallout from the worldwide financial crisis. This is our reality here at Paint Branch; the economic crisis has hit home, and it has hit members of our beloved community.

Each of us needs a place where we can share our stories about our hard times and seek our own personal sense of meaning in the unfolding events of our lives. Coming to terms with hard times is one of the most difficult things in life, and it can be done best in a loving, supportive community such as the one that exists here at PBUUC.

Here are some specific suggestions for things we can, and are, doing at Paint Branch to help each other:

- ✓ Be open and honest about our individual struggles and the challenges that we are facing. There are many resources available in our church community to help those in need, if we are only willing to ask for help. For shy persons, this does not mean you have to stand up during the service and tell everything about your situation in front of the entire congregation during Joys and Sorrows; a conversation with the minister or a member of the Pastoral Care Associates is often all that is necessary.
- ✓ Consider volunteering to help in the church's
 "We Care" program, which helps members and
 friends of the congregation with immediate and
 tangible needs such as a ride to church or a homecooked meal. I understand the program is
 looking for monthly coordinators as well as
 volunteers who can assist with particular welldefined tasks.

- ✓ For those among us who are still managing to make ends meet, consider giving additional donations to this church and other institutions that help people during tough economic times. Many non-profit organizations are reporting that contributions are dramatically down, just when the demand for services is greatest. An extra pledge check or an additional contribution during this time of need could really help make a difference in the lives of your fellow community members.
- ✓ Finally, we can all make an effort to listen during the sharing at Joys and Sorrows, one of the most important regular rituals in our church community. By listening just listening in a loving and supportive way, we create a space where people who are hurting can feel empowered to acknowledge and name their personal struggles in front of a supportive congregation.

Religious Exploration News

TREAD SOFTLY, FOR YOU TREAD ON THEIR DREAMS.

I have spread my dreams under your feet; tread softly because you tread on my dreams.

hese words came to mind when I talked with some of the children and youth here at Paint Branch Unitarian Universalist Church about their dreams for the Religious Exploration Building as the congregation moves toward reclaiming its space.

The Board of Trustees, which held a series of Town Hall meetings on reclaiming the space last month, wanted to make sure that children and youth were heard and asked me to get their input. So we hosted two conversations -- one with children, from kindergarten through 5th grade and another with the middle and high school youth. Both sessions took place during the regular RE time on different Sundays.

The children and I met in the Kelley Room. They brainstormed about what they could do if they didn't have to share the RE building and classrooms. They then drew pictures and used the available materials -- clay, sticks, feathers, glitter, gems and other assorted craft materials -- to give shape to their dreams for the RE space.

In addition to the approximately 12 children, three teachers -- Jan Montville, Marge Owens and Peter Kovac -- attended along with RE Chair Sarah Michailof and Board Trustee Susannah Schiller, who served as recorder. Kweli Powell, our new RE Assistant, and Jennifer Schiller, a youth RE volunteer, helped with the logistics.

Many wonderful ideas emerged from that delightful discussion. Several students talked about drawing murals on the walls or painting rooms and even ceilings with bright colors. Other students, as well as teachers, mentioned the importance of places to display their artwork and other classroom projects.

Children also suggested appropriate-sized chairs, pets in the classrooms, separate spaces for quiet and lively activities, cooking projects in the kitchen and an indoor garden. The teachers mentioned an RE library. Both the children and teachers looked forward to not worrying whether they could use materials and toys in their classrooms.

The children's dreams were not limited to the inside of the RE Building. They also imagined a tree house, gardens, a compost area and an outdoor game area, including a miniature golf course.

After that discussion with the children, the words of Henry David Thoreau came to mind. "Go confidently in the direction of your dreams. Live the life you have imagined."

The youth and I met in Room 1. In addition to the 16 youth, there were four youth advisers (Mike McMenamin, Paul Wester, John Bartoli and Celeste Hall), four middle school teachers (Steven Bernheisel, Kevin Miller, Patty Daukantas and Tina Van Pelt) and RE Assistant Kweli Powell. Appointed board officer Mike Stark, who is also one of the Coming of Age advisers, served as the board recorder.

We took a guided tour of the RE Building of their dreams and a vivid picture emerged. The outside of their building included a chalice mural, PBUUC's name on the building, a fancy and welcoming door, solar panels and a playground near the front of the building where parents could see children from the deck.

Once inside, there are murals on the walls opposite the windows, glass panels perhaps inspired by the Unitarian Universalist principles and the pictures and names of the children and youth in each classroom.

Inside each colorful room, there is comfortable furniture including a couch or bean-bag chairs, pillows, rugs, books, student artwork and projects displayed, and a class-designed mural on the wall. There would also be a youth room designed and decorated by the youth.

The group envisioned transforming the Kelley Room to a place for smaller services and vespers or stage performances. Several students mentioned hanging art work, adding color and putting in rugs.

As Eleanor Roosevelt said, "The future belongs to those who believe in the beauty of their dreams." Listening to the hopes and dreams of the children and youth here at Paint Branch, I am confident of a wonderful future for this congregation.


I was born and raised in Cincinnati, OH. After high school, I attended undergraduate school at Spelman College in Atlanta, GA. My intention in coming to Marvland in 2000 was to attain a doctorate in Biology. However, upon reaching all-butdissertated status, I realized that it would be best for me to take an M.S. in biology instead, in favor of improving instruction in my beloved topic rather than cranking out new data. I taught high school biology for three years and then returned to Maryland in 2007 for a doctorate in science (biology) education (curriculum and instruction). I've thus far completed 2.5 years of a 5-year program (and have been honored with funding provisions that total 6 years!).

My path towards Unitarian Universalism has been a circuitous one; complete with forays into Christianity, the Baha'i Faith, and Buddhism. Beyond all of this, however, the UU principles resonate most with me in light of my (humanistically) Afro-centric upbringing.

Specifically, like UU children, my sister and I were raised to think outside of the standard American philosophical 'box' or worldview with regards to our quest to understand and empathize with our humanity (and that of others). Free and critical thinking, selfempowerment, and cooperation were always highlighted by my parents and the broader community of which we were a part. This psychospiritual-intellectual freedom was, in my opinion, among the most precious gifts that I derived from my childhood. This is because: a) it has spurred my quest for biological and bio-pedagogical knowledge, and, b) it has led to my joining the UU Church, and c) it now comprises my intuitive understanding of the gift that I have been granted the honor of working with the children of PBUUC.

Financial Notes

know those of us interested in the financial stability of the church are concerned about the loss of income from the Montessori School. I include myself in that group. Yet as one who attended all the board meetings, and heard all the reports and discussions, I am very, very proud of the Board and the responsible way they handled this situation.

The Board knew from the beginning that renewing the lease could present us with serious legal and liability problems. On the other hand, they also knew that NOT renewing the lease would allow us to Reclaim Our Space even as it presented a financial challenge.

Starting back in July, the Board consulted a lawyer and organized the Space Options Committee to look into alternatives. Two board members researched the law and the regulations regarding Use and Occupancy. The entire board discussed all the pros and cons. In the end, they decided that the risks and the opportunities of not renewing outweighed the benefits of renewal.

The Board also wanted to bring this to a congregational meeting but two things prevented that: 1) time: the lease required us to inform Montessori by December 15 of our intentions to negotiate renewal or not, and there was no time to have a congregational meeting before then, and, 2) The Board did not want the school to learn that there was a possibility of cancellation if, in fact, it was not certain. In addition, in Maryland, the Board has the fiduciary responsibility to manage the finances of the congregation and they felt that they had to exercise their best judgment in that role.

So what are we going to do? First and foremost we are going to have our normal canvass, organized this year by Pat Tompkins. In order to cover everyone, Pat is going to need lots of help. So --- do NOT say you don't like to canvass. Instead, say, "I may not like it but I know it has to be done, so how can I help?"

To make this easy on all of us, please make your own pledge without prodding. In making your pledge, think long and hard about your commitment to Paint Branch and to Unitarian Universalism. Think of what your life and this world would be without it. Then increase your pledge as much as you possibly can, consistent to continuing that pledge and increasing it in the future.

Again, make your pledge promptly without prodding. We have a number of people who did not pledge this year, yet they continue to contribute. We do appreciate their contributions BUT making a pledge helps the Budget Leadership Team (BLT) come up with a reasonable budget. If we don't how much you plan to contribute, we can't base the budget on it. Remember, a pledge is not a legal obligation and can be changed if necessary at any time.

In addition, we will be trying to increase other rentals. We are looking for continuing renters who do not interfere with our own use of the building. If you have ideas for other ways to bring in income, especially if you are able to organize the project, please let the Board know.

Last, but far from least, a Financial Summit is planned for February where all the financial gurus of the congregation will gather and put together their collective wisdom to come up with more concrete ideas. Stay tuned.

SPECIAL COLLECTIONS

December: The Christmas Eve collections for our Warm Nights expenses, the monthly expenses of preparing and serving a hot dinner to 100 hungry people, and for a contribution to the Warm Nights sponsoring agency (Community Crisis Services, Inc.) totaled \$1.536.

January: We raised a total of \$3,286 dollars for the UUSC/UUA Haitian Relief Fund at our Sunday morning and Martin Luther King services the weekend after the earthquake. This was the congregation's largest special collection in recent memory. We extend our heartfelt thanks to all who so generously contributed. A special collection was taken up on Sunday, January 24, as Paint Branch's gift to Goodloe Memorial UU Congregation, which has committed to funding a \$10,000 scholarship for a Bowie State University student in honor of Don Goodloe, first African-American graduate of a Unitarian seminary and founder of Bowie State University. February: A special collection will be taken on Sunday, February 14, to benefit "I Got Heart," a nonprofit developed by a former Youth Group member, Tip Fallon. "I Got Heart" assists efforts which spring up among high school age people and are often spread through the internet."

An example of such as effort, publicized in the Gazette Newspapers, was a march held some months ago in Silver Spring, following the shooting death of a student at the local high school. The group received \$500 to buy supplies for sign-making, provide tee shirts to the large number of participants, and supply bottled water on the hot day when the demonstration was held. The march was publicized as an alternative to despair and revenge.

UU LEGISLATIVE MINISTRY OF MARYLAND

Several members of Paint Branch are to attend the meeting of the UU Legislative Ministry of MD on Saturday, January 23, where information on pre-filed or expected bills to be supported on issues we have positions on will be available. If you are interested in lobbying on LGBTQ issues, environmental issues, the death penalty, and/or domestic violence, ask Iris Peabody, Fred Teal, or Marge Owens for information. LOBBY DAY FOR LGBTQ RIGHTS, FEBRUARY 8, 2010

Maryland's state legislature had only been in session for 24 hours when the first attempt was made to deny rights to gay and lesbian couples. Del. Emmett Burns, Jr. (D-Baltimore County) introduced legislation (House Bill 90) to invalidate marriages between same-sex couples married in another state or in a foreign country. The bill is currently in committee. We can fight this bill and we can support legislation protecting LGBTQ people by meeting with our elected state officials and telling our stories.

Equality Maryland's annual Lobby Day in Annapolis is scheduled for Monday, February 8, from 4:30 to 8:30 pm. This year we will reintroduce the Religious Freedom and Marriage Protection Act, which will end marriage discrimination against same-sex couples. We will also continue to show our strong support for state-wide anti-discrimination laws protecting the jobs and homes of transgender people and their families. The evening begins with a rally in Lawyer's Mall in front of the State House, and then citizen lobbyists will meet with their elected officials. Our legislators need to be told that we support these laws.

You can drive yourself, join a carpool, or register to ride the Equality Bus with our friends from Cedar Lane UU Church. This is a family-friendly event and legislators are delighted to see children and teens in our lobbying groups.

I will be in the Meeting House Foyer during the Coffee Social with more information about the issues and the Equality Bus. Look for me at a table in the Meeting House Foyer on Sunday January 31 and February 7.

SEVEN: THE INTERSECTION OF KWANZAA AND UNITARIAN UNIVERSLIST PRINCIPLES.

aint Branch's Diversity/Anti-Racism
Transformation Team (DARTT) resolved to
explore the relationship between the seven
principles of Kwanzaa and Unitarian Universalism as
the central theme of its December 30 Kwanzaa
Celebration

By way of a bit of background, Kwanzaa is a made-in-America secular holiday. It was created in 1966 by an African-American scholar as a way of encouraging African-Americans to get in touch with and feel proud of their African roots. Over time, it has grown and flourished to become part of the standard repertoire of seasonal activities in many schools, cultural centers, and the like.

Seven Paint Branchers provided their take on the confluence of Kwanzaa and UU principles. David Chapman, Director of Music and pianist, and Brenda Anna, violinist, provided music. The closing words were sung by Mary Tyrtle Rooker and Carol Carter Walker.

- Evangeline Wells Imani/Faith. The goal of world community with peace, liberty and justice for all.

WITH ALL DELIBERATE SPEED: BROWN V. BOARD OF EDUCATION FILM SCREENING/DISCUSSION DEEPLY MOVING

Fifty-six years after the unanimous Supreme Court decision that ended *de jure* segregation in public education in this country, *de facto* segregation and inequality is alive and flourishing! Right here in our midst. This was the path of the conversation that occurred after the showing of *With All Deliberate Speed: Brown v. Board of Education.* The screening and discussion, part of the Journey of Wholeness Film Series sponsored by DARTT, was led by Polly Pettit, church member and media researcher who did most of the historical footage research for this film. Her insights, including sharing information about some of the participants, illuminated our understanding.

The film covers the usual ground of the well known principals; e.g., Supreme Court Chief Justice Earl Warren, Chief Litigator Thurgood Marshall, etc., but also the ordinary people whose lives were impacted during and after the struggle. Many of the vouth directly involved in the cases became educators. Many of their parents and supporters lost their jobs, businesses and homes, and their lives were threatened. Some in the film, who suffered through the massive resistance used by Virginia to evade the law, spoke of having to leave home and be cared for by foster parents although their birth parents were alive and well. The parents temporarily gave up their children so that they could continue their education out of state. A powerful subtext of the film was the harmful impact of the implementing term devised by the Supreme Court Justices, 'with all deliberate speed,' which, for many resisters, served as a rallying cry.



MEMORIAL SERVICE FOR ROY HART

A memorial service for Royal Hart, a very early and dedicated, long-time member of Paint Branch who died of a heart attack on January 2, will be held at Historic London Town in Edgewater on Monday, February 8, at 2 pm. Mr. Hart was 83.

Roy and his wife, Lois, were very active in the Fellowship for Social Action and as sponsors of the Liberal Religious Youth group. Roy served as board chair in the 1960's and coordinated a Sunday morning Forum that preceded the 11:00 am church service for several years in the 1970s and early 1980s. Speakers included then-Governor Harry Hughes, Richard Cohen and other Washington Post columnists, and various public figures. The forum was very well attended, partly for the fanfare with which Roy wheeled out a continental breakfast each week. He had built an elaborate cart with an electric outlet to hold this extra attraction. More recently, Roy had participated in PBUUC's TWedHUULK lunch group for the past several years. He was married to the former Nancy Dunn for the past ten vears.

In 1962, Roy began a life of public service as an elected delegate to the MD House of Delegates, where he sponsored various civil rights bills. In 1966, he was elected to the MD State Senate, where he sponsored a fair housing bill considered the first such legislation to pass in a state below the Mason-Dixon Line. The state law was soon preempted by a stronger federal law.
